

FAIRFIELD CITY SCHOOL DISTRICT

High School Varsity Baseball Field Use Regulations
(EQUAL ACCESS)

- I. The facility will be available on a first come, first served basis as contracted through the Fairfield City Schools' District Athletic Director. Teams will be scheduled in the order of:
 - 1) Teams which have a minimum of twelve (12) active players who are Fairfield High School students (grades 9-12) and/or graduates of the most recent graduating class.
 - 2) Teams which have a minimum of twelve (12) active players who live within the boundaries of the Fairfield City School District.
 - 3) Teams which do not fit the description of - 1 & 2 above.
 - A) Reservation applications will be available from the District Athletic Director each year between January 5 and February 15. All applications are due into the office of the District Athletic Director by February 15.
- II. There will be a Varsity field rental fee of sixty-five dollars (\$65.00) per official game of use with a one hundred thirty (\$130.00) dollar maximum per day, and for tournament purposes a forty dollar (\$40.00) JV field rental fee with an eighty dollar (\$80.00) maximum/day, plus a game/tournament deposit. The per game fee/deposit is due to the site manager prior to the start of the game.
- III. The site manager will be appointed by the Fairfield City Schools' District Athletic Director. The site manager will be the sole authority regarding use of the facility once it has been contracted through the Fairfield City School District.
- IV. The Fairfield High School Athletic Boosters reserve first right to any and all concessions at any tournament/games. If the Boosters decline their right to the concessions, the Fairfield City School Athletic Director or the site manager has the sole authority to assign the concession rights. The first right of refusal for the concessions after the Boosters will be the remitting team.
- V. The use of the Fairfield High School Varsity Baseball Field will include the field, dugouts, press box, public address system, and, if available, the concession stand. Play may begin no earlier than June 1 and last until the end of Labor Day Holiday, however, the District Athletic Director reserves the right to cancel/postpone games in early June when the Varsity Baseball team is in the State Tournament.
- VI. By Board Policy and State Law, there shall be absolutely no alcoholic beverages at the facility or on Fairfield City School District property at any time. If anyone is found in the possession of or under the influence of any drug or alcoholic beverage, he/she will be arrested and barred from the facility.

- VII. By Board Policy, smoking is prohibited in and on all school buildings, school facilities, school vehicles and school grounds.
- VIII. There are to be no “pepper games” in the infield nor any “soft toss” batting practice on any of the fenced areas.
- IX. All care and custody of the facility during tournaments/games will be the responsibility of the contracting team and its manager under the direction of the site manager. The contracting team is responsible for the clean up after each usage.
- X. In the event that security is needed, the contracting team responsible for securing the necessary services of the Fairfield City Police Department. The cost of such security is to be paid by the contracting team in addition to the field rental fee and deposit. The Fairfield City School District, its Athletic Director and/or the site manager may decide that such security is necessary and require the contracting team to obtain the security. Failure to do so will result in termination of the use of the facility.
- XI. The contracting team may collect admission from the patrons of the tournament/games. The prices will be established by the contracting team.
- XII. Damages and repairs of the facility incurred by the Fairfield City School District, as determined by the site manager, will be added to the final billed total at the conclusion of the event. The Fairfield City School District shall charge such expenses to the contracting team and its manager.
- XIII. All contracting teams must provide proof of insurance coverage for the tournament/games and its participants in the amount of one million dollars (\$1,000,000.00) with the Fairfield City School District named as an additional insured. The Fairfield City School District, its Athletic Director and appointed site manager are released from any legal responsibilities in the event of injury to any participants and/or spectators.
- XIV. The Fairfield City School District reserves the right to cancel any and all tournaments or games at any time due to inclement weather, abuse of the facility, or on the advice of the District Athletic Director and/or site manager. Cancellations following the start of a game(s) will be by the umpire in charge.
