mandate the District may impose would be null and void.

Mr. Smith acknowledged the passion and emotion of people on both sides of the masking discussion. He stated that throughout the pandemic, the Board has relied on guidance from the ODH, ODE and BCHD. Now, however, there is a lack of alignment between the ODH, the CDC and local health authorities. At the same time there is public pressure for school districts to issue their own mask mandates, with equal public pressure to NOT issue mask mandates. Additionally, there is confusion as to who actually has the authority to issue mask mandates. Mr. Smith shared that State Representative, Jennifer Gross, recently signed onto legislation prohibiting schools in Ohio from mandating that students wear masks, stating that it should be up to parents to decide. If this legislation passes, any

The bottom line is that as of August 19, 2021, FCSD is strongly recommending that all students and staff, regardless of vaccination status, wear a facial covering while indoors at school. Students and staff should be treated with respect regardless of their masking decision. The District will continue to monitor its own data.

Mr. Crapo followed up with a slide presentation of recent Covid-19 data, which showed the data by state, by county and by zip code. He will continue to monitor this information as well as our schools' data.

Mrs. Shorter gave a presentation that supported her view that masking is the best way for students to stay in school.

Mr. Clark stated that he is against mandatory masking of students.

Mrs. Gundrum's concern is for keeping kids in school. She would like to know how many kids are wearing masks in school and would like to wait and get more data from our schools.

Mr. Begley said that right now, he is not in favor of a mask mandate, but his opinion could change after we have more of our own data.

Mr. Berding feels that it is the responsibility of the Board of Health, not a school board that is not made up of medical personnel, to issue a mandatory mask order.

He said that the absence left by Naddi has been felt by everyone. He is looking forward to welcoming a new dog to the high school community.

Mr. Clark said that he is glad to hear about bringing the dog back [to the high school].

Mr. Begley inquired about how the dogs will be funded.

Mr. Crapo responded by saying that the cost for South's facility dog is about \$3,000 which will be paid for using security grants and possibly other internal building funds. The security dog at the high school is being donated by the trainer. Additionally, the training for the dog and its handler, Randy Johnson, is also being donated.
