# Positive Adjustments to Ohio's Testing Plan

As we are sure you all have already heard ... the Ohio General Assembly directed the Ohio Department of Education to transition to new assessments during the 2015-2016 school year in mathematics and English language arts. Ohio will be utilizing the same platform as the online social studies and science assessments did last year, AIR (American Institutes for Research). Within the new law, it also states that the assessments will be:

- Shorter than tests given last school year;
- Administered once per year in a single testing window;
- Given during the second half of the school year, with the exception of HS blocked classes that meet first semester; and
- Provide results no later than June 30<sup>th</sup> of each school year.
   Third grade reading will return no later than June 15.

Testing Windows: The buildings will determine the ACTUAL testing days within the window, stay tuned to your building testing coordinator for your building's specifics:

- ⋄ Fall blocked classes HS Nov. 30 to Jan. 8 (15 consecutive days will be selected).
- ♦ Third grade reading (fall) Nov. 30 to Dec. 11 FCSD selected Dec. 1 -7
- ♦ English language arts GR 3-8 and HS April 4 to 29 (15 consecutive days will be selected).
- Math, science, social studies GR
  3-8 and HS April 4 to May 13 (15 consecutive days will be selected).
