I had the pleasure of working with Jerome through not only the school board, but also the Citizens Police Academy of Fairfield Township. He was an avid supporter of both. Jerome served with honor as a member of both entities.

Jerome served on the Board at a time when things were extremely difficult. There were various controversial issues that were being addressed by the board and things were contentious. Jerome was able to play a pivotal and vital role on the board as the cooling saucer. He was fair-minded and direct. He always sought to find common ground. He was a mentor to new board members, myself included, and he did not hesitate to offer good advice. He always had a solution in the making for problems.

It was clear that he loved kids and wanted to do the best for them all. He brought his skills to the board freely and they were indeed invaluable. He will be missed in this community and on this board specifically. People like Jerome are rare indeed. He was a good and faithful public servant who had done well and was called home all too soon. He will be missed.

Mr. Berding shared the following comments:

Jerome Kearns was not only a friend and colleague, he was an incredible individual. When I first joined the Board of Education, I sought advice from Jerome on many occasions. He always listened intently to my questions no matter how minor the subject. If he didn't know an answer, he always took the time to find it for me.

In addition to being a devout Christian, who did wonderful things in his church, Jerome was a servant leader who led by example. Jerome always conducted himself professionally and with the upmost integrity. Jerome's passion for the welfare of children showed through his work at the county as well as here at Fairfield City Schools. Jerome never cared if his decisions were going to be popular. His only criteria for the decisions he needed to make were if they were in the best interest of children.

During his tenure here on the Fairfield Board of Education, Jerome made significant contributions such as he helped develop Fairfield Schools Master Facility Plan, helped repurpose other school buildings within the district (Fairfield Administration Building and the Fairfield Academy), opened our School based Health Center, and pressed for the renovation of Fairfield Stadium.

I could state other examples of Jerome's passion to serve others, but they are too numerous to list.

Jerome's efforts here at Fairfield City Schools will live on for generations. I thank God for bringing Jerome Kearns to Butler County and Fairfield City Schools. He will be missed by all, especially me.

I hope to see him again someday.

Mr. Begley stated the following:

As the newest member of this board I only had the privilege of knowing Jerome for about a year and a half. We became fast friends based on our shared faith and our love-hate relationship with running.

I admired Jerome and looked up to him for guidance as I joined this board. He was a man of great character and integrity and after many years of service to the children of this district, he had quite the knack for asking the right question or summing up a difficult topic.

The district and this board has lost a great friend but far more tragically a family has lost a husband and a father. My prayers go out to them and I lift them up to be comforted in this most difficult time to mourn the loss of one so dearly loved. God bless.

Mr. Hare shared the following comments:

I first met Jerome when the Butler County Job and Family Services employed him.

I supported Jerome in his election to the school board because I found him to be a person of high character and integrity. He was always thoughtful in making decisions in the best interest of children. He was an advocate for providing countywide services to children and families and providing outstanding educational and extra-curricular experiences for our students.

Jerome was always consistent in adhering to his values and mindful of the role he was in whether it was Board president, Board member, employee, friend, father or husband. He didn't need a title because he was a leader by example. I always cherished our discussions whether they were about important topics on to how make Butler County or the Fairfield City School District a better place to live and raise children or about simple insignificant issues like which way the four foot putt will break.

We lost an excellent leader, an outstanding Board member, advocate for children and a personal friend. He was a friend to all and will be greatly missed.

COMMITTEE REPORTS

A. Legislative Update - Michael Berding

Mr. Berding updated the board on the following:

Governor Kasich appointees, Tess Eishoff and Nancy Hollister, have been elected as the 2017 Ohio State School Board President and Vice President respectfully.

The governor has also requested all state agencies submit two budget proposals, one at 100% funding and one with 10% cutbacks. The State Board of Education has proposed an additional \$25 million over two years to help serve an additional 6250 children of low income families to help bridge the achievement gap. That would bring their total to \$95 million/year.

Next week a few members of the Butler Tech BOE, including myself, will be attending the 2017 Ohio ACTE Legislative Seminar in Columbus. While we are there, we have meetings scheduled with several State Senators and State Representatives to discuss new state laws affecting schools and school funding. I will update you at our February meeting on the results of these conversations.

Mr. Begley was kind enough to share the following information with me regarding new laws in effect as of January 12, 2017:

Lindsay's Law helps prevent sudden cardiac arrest in young athletes. Along with concussion guidelines, students and parents now have to review standards and protocols about sudden cardiac arrest, and coaches are required to complete an annual training course on the condition.

STEM (science, technology, engineering and math) curriculum can now start as early as kindergarten. Programs are available that help to guide students on the educational path that will carry them through their primary education.

Truancy: Schools can no longer suspend or expel a student just for excessive truancy. Districts with truancy levels over 10 percent are required to implement an absence-intervention team in an attempt to avoid truancy charges.

Snow days: The Ohio Department of Education will no longer have to approve a district's plan to make up snow days or the "blizzard bags" that schools send to students' homes. Schools will work out a solution on their own.

I emailed everyone on the board and on the leadership team the January 2017 Butler Tech Student Success update. I also have extra copies for Mr. Clemmons and our newest board member, Mrs. O'Neal. Please share it with as many people as you wish.

I hope you had a chance to read about Senator Rob Portman's visit to the Bio Science Center in December. Senator Portman was very impressed with the work the students are doing, saying it is "cutting edge in the country" and students are being exposed to the medical profession that is normally seen in medical school - not even in undergraduate school- and these are juniors and seniors in high school. There are many other success stories, including Adult Education.
