The Board of Education of the Fairfield City School District in the County of Butler, Ohio, held a Work Session on the 2nd of February 2017 in the Catherine D. Milligan Community Room.

PRESENTATIONS/RESOLUTIONS

A. Transportation 2017-2018 – Bill Westerbeck
Mr. Westerbeck presented an overview of the transportation times for next year.

Mr. Hare asked if the plan requires us to purchase additional buses. Mr. Westerbeck stated that additional buses are not needed; all 67 buses will be used.

Mr. Hare asked if we will be purchasing new buses this year; we will purchase five new buses. We will trade in old buses.

Mr. Hare asked if the additional cost of \$180,000 for sophomore busing is for personnel. Mr. Westerbeck stated that the monies will be used for additional staff hours.

Mrs. Shorter asked why the start times are shifting from East to North. Mr. Westerbeck stated that the lower number of students in those buildings require less buses.

Mrs. Shorter asked how many buses would need to be purchased to make all of the elementary start and end times the same. The answer was 24 additional buses at \$93,000 for each bus as well as \$53,000 additional cost for wear and tear on the buses and for drivers. That would be a total additional cost of \$146,000 per bus.

B. State of the District – Billy Smith
Mr. Smith gave an overview of the status of the District including Academics, Personnel,
Communication, Building Project and School Based Health Center.

Board Member Comments

Mrs. Shorter

She reminded everyone that the start time for the high school was addressed in the past by parents and students that made an appeal for a later start time for the high school. Their argument was supported by studies that indicate the need for more sleep for teenagers. She can attest to the struggle she has had as a parent getting a student up early. She also noted that high school students have a great deal of homework.

Board Member Comments (continued)

Mrs. Shorter

She also referenced state changes that will reduce transportation allocations; she will point out those changes in a report later in the meeting. The increase in the number of drivers to alleviate some of the concerns is just too costly for the district.

She sees the changes in start and dismissal times as an opportunity for parents to view the situation as a chance for kids to learn to grow and make adjustments. She does realize that this is a difficult transition and she will keep that in mind as she votes on this issue. She has been through a number of building transitions with her own children and feels that the reduction of building changes for students will be helpful.

Mrs. O'Neal

She is worried about the Tier 4 students; the students who will be adjusting their school day by two hours. She is optimistic that the decrease in the number of transitions to buildings will be positive. All is right about the changes to allow the 10 year old fifth grader to experience the school size of 800 in the ninth grade rather than in the fifth grade.

She wishes we had the financial ability to adjust the start and dismissal times, but we do not have the money. She realizes this is painful and she does have concerns.

Mr. Begley

He is concerned about the two hour shift for some of the students also.

He noted that including the sophomores in busing is a big positive and that he has heard favorable comments from students and families about the issue. He admitted that there are so many factors to consider in this decision that it is not an easy one.

Mr. Hare

He pointed out that if you change one aspect of the transportation issue, it has a ripple effect. It is a difficult decision that will have a positive impact on some families and a negative effect on other families. Unfortunately, we cannot accommodate the needs of all of the people all of the time.

COMMITTEE REPORTS

Legislative Update – Balena Shorter presented the following:

There are 2 main items of note that the public will be updated on. One pertains to the budget recommendations for fiscal years 2018-2019 presented by Gov. John Kasich Jan. 30th and the other is the draft overview of Ohio's ESSA state plan.

The Every Student Succeeds Act (ESSA) was signed into federal law on Dec. 10, 2015, replacing the No Child Left Behind Act (NCLB). Per legislation, each state is required to communicate with stakeholders in order to gather input for their state plan.

• 15,000 Ohioans provided info about their thoughts about the plan.

FAIRFIELD CITY SCHOOLS BOARD OF EDUCATION WORK SESSION FEBRUARY 2, 2017

- Approximately 3,100 individuals participated in 11 webinars
- 1,500 Ohioans attended the 10 regional meetings held across the state;
- There were more than 11,000 responses to the ESSA online survey; and
- Department staff participated in more than 70 meetings and presentations around the state and collected suggestions and recommendations submitted through email to the Department.

Here are a few of the major policy points included in the draft summary report:

- One of the main themes communicated during stakeholder engagement was the need for stability in
 the state testing system, as Ohio has changed tests two times in the last three years. Accordingly,
 Ohio is proposing to maintain its current state assessment system. However, the Department will
 work in partnership with Governor Kasich and the General Assembly to re-examine any state
 assessments not required under ESSA.
- ESSA requires each state to set a time period for state-level goals; Ohio has selected 10 years. The metrics for which we establish long-term goals include: percent proficiencies in math, ELA, and science; performance index; graduation rates; chronic absenteeism; and English language proficiency.
- Reducing the threshold number of students for which a subgroup of students must be separately reported for accountability purposes (N-Size) from 30 to 15 to ensure that more student subgroups are identified in an effort to provide targeted interventions.
- Ohio proposes to use chronic absenteeism and discipline incidents as its initial indicators of school quality.
- Ohio will build on the existing School Report Card measures and weighted frameworks by reviewing and/or making revisions to several measures.
- State set asides in title funding will be redirected back to local school districts strategically.

Ohioans are encouraged to submit comments to the draft summary and to the full report beginning on Feb. 2 through March 6. After edits and comments are received, the full draft plan will be submitted to the U.S. Department of Education in April.

Gov. John Kasich announced his education budget proposal

On January 30th, Gov. Kasich presented his budget recommendation for FY 2018-2019. Following are highlights of the education funding plan:

- An adjustment to the pupil transportation formula is the only change to the formula. It reduces the minimum state share percentage from 50% to 37.5% in the first year and 25% the second year.
- The gain cap would be 5% both years.
- The per pupil basic aid amount would remain at \$6,000 both years.
- The remaining components of the formula will be unchanged from the current FY 2017.
- The guarantee would be reduced on a sliding scale for districts that have lost more than 5% ADM since FY 2011 at 1% for each incremental percentage lost (maxed out at 95% guarantee). As examples, a district with a 6% ADM loss would have a 99% guarantee. If a district has lost 17% of its enrollment in the past five years, it would receive a 95% guarantee. This will be calculated once, and the results would be used for both years of the biennium.
- Districts below the 5% ADM loss or with increased enrollment can receive a 100% guarantee based on FY 2017.
- \$280 million total increase to education over the biennium.
- Tangible Personal Property (TPP) replacement is unchanged from current law.

We will further update the public once bill language and school district simulations are made available.

Upcoming US Education Secretary Senate Vote

Also, the Senate will be voting on Betsy DeVos for Education Secretary. Most funding for public schools are relegated to the local and state shares. Title funding is allocated by the federal government. Public schools can't afford to lose any funding regardless of the source. Funding is a critical issue that impacts all that we do. The concerns about Charters and public schools funding reallocation is the issue that many are concerned with. Contact your Senators to make your voices heard.
