# RESOLUTION DECLARING THAT A CASE OF URGENT NECESSITY EXISTS AND AUTHORIZING ENTERING INTO A CONTRACT WITHOUT ADVERTISING OR COMPETITIVE BIDDING FOR TENNIS COURT REPAIR AT THE FAIRFIELD HIGH SCHOOL

WHEREAS, while performing repairs on the tennis courts at the Fairfield High School, additional deterioration was discovered to such a degree that the courts cannot be used, and,

WHEREAS, the additional repairs of the tennis courts must be accomplished immediately to prevent further deterioration and to enable their usage this school year,

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Fairfield City School District, County of Butler, State of Ohio, that:

<u>SECTION 1.</u> It is found and determined pursuant to ORC 3313.46 that there is an urgent necessity for the additional repairs of the tennis courts at Fairfield High School.

<u>SECTION 2</u>. It is further found that compliance with the procedure for advertisement and competitive bidding prescribed by ORC 3313.46 would delay the commencement of said additional repairs for an excessive period of time causing an additional burden on the district.

<u>SECTION 3.</u> The Treasurer and the President of the Board are hereby authorized to contract without advertising and competitive bids with:

Barry L. Brown Paving 3210 Homeward Way Fairfield, OH 45014

For the additional repairs of the tennis courts at Fairfield High School in an amount not to exceed \$116,000.00.

<u>SECTION 4.</u> It is found and determined that all formal actions of this Board of Education concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such action were adopted in meetings open to the public, in compliance with all legal requirements including ORC 121.22.
