A. Equity Progress Report – Equity Leadership Team

The Equity Leadership Team presented an update to the Board regarding equity activities happening in our District.

Mr. Smith thanked the Equity Leadership Team for their efforts and the Board for their support. He reminded everyone that the plan is a guide and it does not restrict what the team does if a need is identified to benefit kids.

Board comments:

Mrs. Shorter thanked the team for the great work that they are doing.

Mrs. O'Neal thanked everyone for what they are doing. She is amazed that we have over 40 languages being served in our district. She noticed the flags at the high school that represent the countries of origin for our students. She is glad that we do not fear failure when we make decisions. She was also happy to see that health solutions are part of the plan.

Mr. Berding stated that tremendous work is represented in the team's work.

Mr. Berding wanted to know if the flyer sent to Tyler's Creek was available in Spanish.

1. Memorial Bench at Central Elementary - Tom Weiser

Mr. Weiser advised the Board that the bench will be five feet long and the total cost will be \$2500.

Mrs. Shorter thinks that the font should be changed on the sample provided.

Mrs. O'Neal will send several "mock ups" to the Board for their opinions.

2. Soccer / Lacrosse Field Turf- Tom Weiser and Mark Harden

The Board was asked to consider the installation of turf on the soccer/lacrosse field. The process to provide turf on the soccer/lacrosse field would take sixteen weeks. The state pricing for the cost is \$575,700 for the field only.

The field has been unusable at times due to flooding. Estimates have been made on a drainage system that could cost \$14,350.

The storm drainage behind Crossroads would cost an additional \$54,565 for a total of \$644,615. A contingency cost of \$45,000 brings the total to \$689,615.

3. Policies - Lani Wildow

 a. Policy IGBB – Programs for Students Who Are Gifted Rob Beidelman presented.

Mrs. Shorter asked what tools are being used for assessment of students. Mr. Beidelman's response: CogAT testing, as supported by the Ohio Department of Education, is being used for assessment.

4. Cooper House - Dan Hare

Mr. Hare read the following statement:

Recently there has been discussion about the fate of the Cooper House. It is a Fairfield City Council issue that has been discussed at the Parks & Recreation Board, at the Planning Commission and at City Council. The School Board heard a presentation from students at the November board meeting. In each of these settings, the School Board has been mentioned as a possible supporter and even a possible donor.

He then asked Mr. Smith to share the information about Cooper House and how the information came to the Board's attention.

Mr. Smith stated that he had met with Dean Bruewer of the Parks & Recreation Board and with Jen Carroll, a high school teacher, regarding the Cooper House. The Parks & Recreation Board was asking for the Board's support to be stated publicly to save the Cooper House for educational purposes.

Mr. Hare then read this statement:

This is clearly a City Council issue and not a School Board issue.

We would no more tell the city what property or buildings to purchase or sell than they would tell us what we should have done with the old Central building. Central was our responsibility and our responsibility alone. We don't advise the city how to spend its financial resources and they don't advise us how to spend our financial resources.

We don't oppose or support governance issues that are city or township issues. Recently, a member of the Board of Township Trustees asked our opinion on several zoning issues. Our response was "we have no opinion as it is not our responsibility, we don't oppose or support responsibilities that are clearly the township's responsibilities.

Mrs. O'Neal is a member of the Parks & Recreation Board. She thinks that it has been great to see Fairfield City School District's students engaging with the city and brainstorming creative ways to influence the city's decision.

Mr. Begley stated that Mr. Hare had summed it up – the Cooper House is owned by City Council and we have no right to decide what will be done with it. He does appreciate the compassion of the students.

Mrs. Shorter agrees with Mr. Begley. It is an issue for the city of Fairfield. The Board maintains their domain and the City has theirs.

Mr. Berding stated that it is not good practice to tell other municipalities what to do with their property.

Mr. Hare stated that the Board wishes the City well and asked Mr. Smith to communicate the Board's decision to the stakeholders involved.

Mr. Smith stated that he would do so.

5. English as a Second Language Staffing Needs - Lani Wildow

A presentation of staffing needs was made by Lani Wildow and Laurie Gage.

Mrs. O'Neal asked if it would be hard to find a half time ESL tutor. Mrs. Gage replied that the position has been posted, so there is a large pool of applicants.

Mr. Beding read the following statement:

I emailed the December edition of the <u>Transforming Lives</u> newsletter earlier this week. In the newsletter you can read about:

- Veterinary students training a cat to make a theatrical debut.
- Proctor & Gamble spoke to students about opportunities in STEM.
- The City of Fairfield donated a fire engine to help our Firefighting Technology students participate in more field exercises.
- Butler Tech students designed a custom adaptive bicycle for a child with disabilities.
- Several Fairfield students performed well at the FCCLA cluster competitions. Sydnie Hocter and Madi Flick finished 1st and 2nd respectively in fashion sketch. The Knowledge Bowl team of Taylor Ferrell, Jacquelinn Gasdorf, Hunter Martini, Olivia Potunas, and Sarah Radcliffe were one of 12 teams in the nation to qualify for the National competition to take place in Atlanta next summer.
- Project Life student Nick Simmer was featured in the Journal-News and on WCPO as a student with Autism who turns his artistic talents into tools teachers can use to help students with autism cope with issues.
- I again had the pleasure of speaking at the Basic Police Academy graduation this past Saturday. There is a sense of pride celebrating these future heroes completing their basic training to become police officers.

Butler Tech is in the investigative stages of adding an Aviation Pathway to our programming. We are in discussions with several local airports to secure space for classrooms for the 2019-2020 school year.

Butler Tech is also developing an interactive app to allow all parents and students access to details of our programs as they research possible enrollment.

Butler Tech staff presented at the National ACTE convention earlier this month. Twelve staff members hosted seven seminars about what we are doing at Butler Tech. One session given by Superintendent Jon Graft was standing room only with attendees hovering in the hallways listening to Jon discuss innovative ways of teaching career tech.

Lastly, Butler Tech has started to roll out our new logo to start our rebranding campaign. Look for new names of our campuses to help identify them easier for our parents and stakeholders. For example, D. Russel Lee on Route 4 will be known as Butler Tech - Fairfield Township Campus.

Each building there will also be given names, such as D. Russell Lee building, James Boyd Educational Resource Center, etc. Our other campuses will be named Butler Tech - West Chester (BioScience Building), Monroe (Natural Science Building), Liberty (Public Safety Education Center), and LaSourdesville Adult Education Headquarters).
