COMMITTEE REPORTS

A. Legislative Update – Balena Shorter

Mrs. Shorter presented the following report:

House Bill 512:

Creates the Department of Learning and Achievement to oversee primary, secondary and postsecondary education.

Specifies that the Department is administered by the Director of Learning and Achievement, who is appointed by the Governor with the advice and consent of the Senate.

Requires the Director to appoint an assistant director to oversee higher education and an assistant director to oversee the Office of Workforce Transformation within the Department, and permits the Director to appoint other assistant directors as the Director determines necessary.

Transfers to the Department (1) most of the powers and duties of the State Board of Education, Superintendent of Public Instruction and Department of Education and (2) all of the powers and duties of the Chancellor of Higher Education, Department of Higher Education and Governor's Office of Workforce Transformation.

Abolishes the Department of Higher Education and the Ohio Board of Regents, and eliminates the position of Chancellor of Higher Education.

Specifies that the State Board of Education, Superintendent of Public Instruction and Department of Education continue to exist for prescribed purposes.

Retains some of the existing powers and duties of the State Board, Superintendent and Department of Education, but transfers rule-making authority regarding those powers and duties to the Department of Learning and Achievement.

Transfers specified responsibilities of the State Board and the Department of Education to the Superintendent of Public Instruction.

Transfers the responsibility to adopt rules pertaining to comprehensive emergency management plans to the Department of Public Safety.

(This bill would seemingly undue the will of the voters who voted to establish a state board of education and to remove the Superintendent of Public Instruction from the governor's office in 1953. The board was created to be an independent body via an elected membership. There is strong opposition to House Bill 512).

Senate Bill 216 – Reducing Mandates:

There are some specific provisions in the Senate Bill that impact the College Credit Plus Program.

The Senate Education Committee accepted amendments which include the following:

Requiring students to pay half the cost of textbooks under the College Credit Plus Program unless their family income is at or below 200% poverty guidelines.

Revising the teacher evaluation framework

Revising educator license grade bands to grades K-5, 4-9 and 7-12.

Creating temporary educator licenses to teach in Early College High Schools

B. Butler Tech – Michael Berding

Mr. Berding read the following report:

There is a nice article in the Journal News this week called Seven Things that make Butler Tech one of the most unique and innovative districts around. I will forward the board and leadership team the link to the article.

Some of Butler Tech's Cosmetology students spent a day giving makeovers to women at Juliette's Hope Women's Center in Hamilton. Juliette's Hope Women's Center is a non-residential community of women helping broken women heal from physical, sexual and emotional abuse, prostitution, sex trafficking, drug addiction and other life controlling issues.

FHS had four BPA national qualifiers resulting from the state competition. I will forward their names when I get them.

Negotiations with Hamilton City schools continue to progress since they asked Butler Tech to consider talking over their ACTE programming.

Butler Tech is working with some local governments to help recruit new police and fire and EMT/paramedic candidates. There is a nationwide shortage of these professionals, and Butler Tech hopes to increase the talent pool.

Last week a group of us from Butler Tech were in Washington DC talking with legislators promoting public education. We stressed deregulation of public education as a means to fill the skills gap our region is facing. I am providing each of you a copy of one of the handouts that we gave our legislators. It's called Butler Tech by the Numbers. It shows the number of students, both full-time and part-time, (totaling 17,000) and the different fields of study they take. About 45% of 6-12 graders in Butler Tech associate schools take at least one Butler Tech class. The back side of the handout shows that 90% of the students who completed a two-year course at BT were either employed, in the military, or engaged in post-secondary or advanced training within six months of graduation. It also shows college credit plus and Career Transfer Assurance Guide Credit numbers. 52 Industry credentials are available for students to earn. Plus over 1000 work based learning experiences at local business were documented in 2017.

At the OSBA southwest spring conference Butler Tech board member from Northwest Local SD was named Board Member of the year and Dr. Laura Sage was named Administrator of the year.

Mr. Hare and I enjoyed a nice lunch at Butler Tech's Café Lee prepared by Fairfield senior Derek Clark-Grubbs. Mr. Hare had a curried coconut soup and spring rolls and mango sorbet, while I enjoyed the shrimp Pad Thai and banana custard. It is open again tomorrow from 11:30am – 1pm.
