A. Legislative Update – Balena Shorter

House Bill 122 – Based on the proposed recommendations, this could lead to more money for the district.

Senate Bill 36 – Rental property valuation changes could impact the school district.

House Bill 118 – Pupil transportation services cannot reduce within the school year.

One million dollars was added to the budget to supplement school facilities. That is not nearly enough money to assist districts awaiting financial assistance.

B. Butler Tech – Michael Berding

Performance Toyota came to the Fairfield Township campus to interview juniors looking to fill two spots. They hired all six juniors that applied. Dozens of juniors will be working this summer in their field of study.

More than 80 Butler Tech middle through high school students competed in Anaheim California for the BPA national competition. Butler Tech students earned: Twenty-four TOP Ten in the Nation Winners, One - Third in the Nation Winner, and Nine - First in the Nation Winners.

Levi Grimm from Ross finished first in the Nation in the DECA (Distributive Education Clubs of America) – Hospitality and Tourism Professional Selling category, a first for a Butler Tech DECA student.

Butler Tech will honor 70 National CTSO qualifiers at our May 21st meeting.

Mr. Berding thanked the district for assistance with English testing procedures for sophomores. Katie Pospisil was instrumental in providing guidance.

On May 13th the Butler Tech Senior Ceremony took place at the Cintas Center. 575 seniors were honored for completing their career focused studies. Most seniors who were eligible to earn an accreditation received that also. State regulations require that some of the seniors will have to wait until after graduation to apply.

The family of New Miami student Brayden Leaker was presented with the first certificate. Brayden, a senior Construction student at the Fairfield Twp. Campus, passed away in a car accident on Saturday, May 11th. Our Hearts go out to the Leaker family and the entire New Miami community on their loss.

Mr. Hare asked how this year's graduating class compared to last year. The size is about the same per Mr. Berding.

Butler Tech had to turn away 900 sophomores who applied as incoming students for next school year.

Mr. Hare wonders if corporate sponsorship could allow Butler Tech to grow some of their programs. Mr. Berding stated that corporate donations have been received. Mr. Berding further stated that there is a group of companies that have been labeled as the "G10" who work together to fill staffing needs.

Mrs. Shorter was interested in more information regarding the Toyota recruits. Mr. Berding stated that the students were in the general automotive program.
