The Technology Plan for Fairfield City School District was presented to the Board.

Board comments followed the presentation.

Mrs. Shorter stated that she does love the idea of technology.

She asked if this will eliminate textbooks.

Response: Not necessarily, the students usually work from a laptop cart and a class set of textbooks. The decision to eliminate textbooks has not been made at this point.

Mr. Begley is a huge fan of this. The panel answered all of his questions with the presentation.

Mr. Gundrum asked if replacement costs have been included in the budget numbers.

Response: There are some replacement costs included.

The district has insurance to cover one time per year replacement costs for parts.

A district policy needs to be established to make the student responsible for additional replacement costs as well as loss of the devices.

Mrs. Gundrum asked about screen time.

Response: In the kindergarten setting, the screen time will be minimal.

The device is a tool. The panel does not expect the students and teacher to be on the devices all day.

Mrs. Gundrum stated that the presentation was very informative.

Mrs. Shorter asked what happens when the student does not have wireless access at home. The staff and the students will need to work together to make sure that the student has hard copies of the material to take home or that the student downloads the material before they leave the classroom. Planning ahead will be necessary.

Mr. Berding asked if the fee charges is \$40 per year.

Response: Yes, but there is no fee for kindergarten through fifth grade.

Mrs. Shorter asked if there are enough resources planned for the high school. She thinks that we need to look at that for the future.

Response: The committee recommended 2 additional teachers as they tried to pick a number that was fair.
