RESOLUTION OPPOSING THE STATE OF OHIO EdCHOICE SCHOLARSHIP (VOUCHER) PROGRAM

WHEREAS, the Ohio legislature has recently made amendments which greatly increase the number and availability of vouchers for students to attend private/parochial schools at public tax expense, and

WHEREAS, such vouchers will be available to numerous families and students who have never attended Fairfield or any other public schools and for whom state funding has never been provided to Fairfield or any other public schools, and

WHEREAS, Fairfield's state funding will be unjustly decreased by the amount of the vouchers provided to such families and students who have not and will not attend public schools and others who transfer to private/parochial schools, and

WHEREAS, the estimated loss of revenue to the Fairfield City School District over the next four (4) years is \$14,530,950 which would devastate the District's finances, and

WHEREAS, private/parochial schools accepting students with public tax vouchers would not be required to accept all students but would be permitted to retain their selective admission policies without enforcement of other laws applicable to public schools, and

WHEREAS, private/parochial school students are not subject to the testing standards required of public school students so that the actual performance of private/parochial schools subsidized with public tax dollars will not be known, relative to equivalent public school evaluation standards, and

WHEREAS, this Board believes that the EdChoice voucher program as it currently exists presents serious constitutional issues regarding the separation of church and state and the funding of religious institutions with public tax dollars, and

WHEREAS, the State of Ohio has the constitutional responsibility to secure a thorough and efficient system of common schools, and

WHEREAS, the EdChoice voucher program will have exactly the opposite effect by providing funding to private/parochial schools at the expense and to the detriment of public schools and their students.

NOW, THEREFORE, BE IT RESOLVED by this Fairfield City School District Board of Education that this Board reaffirms its commitment to free accessible public schools which are adequately and equitably funded to guarantee a comparable education for ALL children and therefore opposes and respectfully requests the repeal of the ill-conceived EdChoice voucher program of the State of Ohio.

BE IT FURTHER RESOLVED that this Board opposes any funding programs, vouchers or otherwise, that have the effect of diverting public tax dollars from public schools to private/parochial schools.

BE IT FURTHER RESOLVED that the Treasurer is hereby authorized and directed to forward copies of this Resolution to all Ohio state legislators, the Superintendent of Public Instruction and Governor of the State of Ohio.

COMMITTEE REPORTS

A. Legislative Update – Balena Shorter

EdChoice Expansion and HB166. The changes are listed below.

Impacts our State Funding Share

There is not really a cap on the amount of EdChoice vouchers as there was before.

HB 166 expanded the EdChoice Scholarship program in multiple ways. The bill requires ODE to increase the cap on the number of EdChoice vouchers available (increase the cap by 5 percent each time 90 percent of available vouchers are claimed) this increase applies to the **original EdChoice** program where students are eligible based on so-called 'failing schools.' This program is funded through deductions from school district state payments.

Students never had to attend a public school in order to qualify for a voucher. Generally, students wishing to claim a voucher under the **original EdChoice** voucher program must have attended a public school in the previous school year. However, HB 166 codifies in law the current practice where students going into grades 9 through 12 need not first attend a public school. In other words, high school students already attending a private school can obtain a youcher.

Does not Impact our Funding Share

The income-based EdChoice voucher program was expanded in HB 166 to include all grade levels.

The income-based EdChoice voucher program is expanded in HB 166 to include all grade levels (rather than phasing in grade levels year by year). In FY 2019, students in grades K through 5 were eligible. Students need not first attend a public school to be eligible for this voucher; the qualifier for the income-based voucher is families at or below 200 percent of poverty. The voucher amount is prorated according to income. This program is funded directly by the state and not deducted from school districts' payments.

Mrs. Shorter

Mrs. Shorter read the following statement:

I'm a believer, supporter and product of public schools. There is a special trust engendered between the citizenry and public schools in general. The charter of most public schools is to educate all within its geographical boundaries regardless of income or abilities. This is a sacred compact that keeps this country great. I also support parental school choice, but not at the expense of financial stability and the well-being of public schools. Right now, in our great state of Ohio, many public schools are under severe threat because of legislation that was tucked away in a recent bill that was signed into law by Governor DeWine. This provision escaped the disinfectant of legislative and public scrutiny it so richly deserved.

The Expansion terms of the EdChoice program threatens many districts with the possible elimination of millions of state allocated dollars. Fairfield City Schools receives roughly 33.9 million dollars in state funds per year. With our predictions of EdChoice Expansion voucher usage, our district could lose over \$3.4 million in state dollars in one year. That's 10% in the first full year of the program. Unfortunately, it does not end there. In 5 years, EdChoice Expansion vouchers could spell the loss of over \$14 million for Fairfield City Schools. No state politician would stand openly for cutting the education budget by 10%! They would incur the wrath of the voting public. Instead, public school monies are being siphoned away through an opaque process designed to help lawmakers avoid accountability. It's simply not what democracy is about.

I'm asking all who support public education in the state of Ohio to reach out to your individual State Representative and Senator and encourage them to address/correct this problem. Call Governor DeWine and tell him to support and protect public schools by making funding for public schools whole.
