Mr. Berding read the following statement:

On January 28, we cut the ribbon on the addition to the Bio-Science Building on the West Chester Campus.

A group of Butler Tech staff and board members spent Wednesday and Thursday of this week in Columbus meeting with our representatives and senators to discuss school funding and other pressing matters. Everything from EdChoice vouchers, the funding formula, cap and guarantee were extensively discussed and the impact that they will have on public education in Ohio. We feel we reached a few of them. We also discussed eliminating some of the unfunded mandates as a way of freeing up money for the local school districts. I was in the chamber and witnessed the house vote 88-7 to pass Senate Bill 89 with an amendment addressing EdChoice.

The January priority deadline for applications into Butler Tech for the 2020-2021 School year has passed.

2188 overall applications for 950 seats = 57% turned away 386 applications for 150 10th grade academy seats = 61% turned away 96 applications for 75 Information Tech seats = 22% turned asway 89 applications for 25 Welding seats = 72% turned away 218 applications for 100 Healthcare Science seats = 54% turned away 42 applications for 25 Mechatronics seats (2nd year) = 40% turned away Aviation Exploration at full capacity of 25 students (2nd year)

Tomorrow starts the first Friday of Butler Tech's Fifth Day Experience. I have distributed some data related to the program.

475 students will be attending an activity on our campuses on a non-school day. We had 1013 applications for activities that have a one-time occurrence tomorrow. (Some students will be taking advantage of multiple things each Friday.)
268 students signed up for every Friday classes. Many more students will be working, interning, taking driver's education and making college visits. There have been 4147 applications so far for additional educational experiences.

I have also included a page on some of the offerings that are full and the number of students on a waiting list. Driver's Ed filled up within 90 seconds of the application window opening. We are exploring adding another class.

Dunk & Donate is a fundraiser being held on Friday, March 20th at Miami Valley Gaming from 2:00 – 7:00 pm. It is a fundraiser to help students to pay for their trade tools including welding helmets, gloves, knives, cosmetology scissors, etc. Tickets entitle you to appetizers, desserts, two drinks and a \$10 gaming card.
