FAIRFIELD BOE NEEDS TO TAKE A CUE FROM LOCAL COST CUTTING AGENCIES.

The local headlines continue to inundate us with the reality of the hard economic times we are facing. I would like to share a few headlines with the board and ask that the board consider cost cutting actions of the government agencies involved

"Economic hardship hits the "king of jails" The Butler County Sheriff is asking for cooperation from local law enforcement to reduce the jail population. The Sheriff said "We all

have budgets to watch. Putting people in jail is costly for taxpayers. Alternatives to jail such as ankle-bracelet monitoring, probation, reduced bonds, perhaps night court, are all things to be considered. In the mean time, I need to manage my jail like a business."

"City looks to unions for budget cuts" The Hamilton city manager said he would be meeting with the cities unions to discuss possible concessions in an effort to save money. The mayor said he is hoping each union is able to give a little to help balance the budget.

"Auditor making headway on major objectives" The Butler County auditor said his agenda focuses on reducing costs, improving customer service and increasing office transparency. He also said he cut \$500,000 from his budget in his first 3 months of service. At the same time he has reinforced his commitment to deliver reliable customer-oriented services to the citizens of Butler County. According to his office the Auditors 2008 projected budget \$7,700,000. This means he cut 7% of his budget in his first 90 days of service and is still pledging reliable customer oriented service to the taxpayers.

Now comes the Fairfield Board of Education. Facing a \$6,000,000 shortfall this school year. What have we done to save money or balance our budget? With all the economic hardship our community is facing we increase the tax burden on our community with a new PI Levy. With a \$79,000,000 budget projected for this year, Mr. Murray and Mr. Kearns share 5 cost cutting ideas that squeeze out a scant \$254,000 in savings.

I will remind the community that I have been asking the board to make cuts for almost 3 years. I shared 33 cost cutting revenue generating idea with our board back in May and instead of discussing them they were ignored. By my estimate these ideas conservatively represent over \$10,000,000 in savings. The sad thing is, of the 5 ideas Mr. Murray and Mr. Kearns shared with us, at the last board meeting, two of them are from my list of 33.

This BOE has asked the community to support a new PI levy this year. Unless we can come up with millions in savings this year we will have a multi-million dollar Operating levy next year and we have yet to even discuss the Bond Levy that will be needed to pay for the new classroom space we desperately need. It's time for this BOE to come to terms with the communities hard economic times and take a cue from the other government agencies who are living within their budgets.
