## A. Items for Board Discussion

1. Request for Dan Murray's attendance at the National Science Teachers' Association conference, April 3 – 6, 2014 – Paul Otten

Discussion regarding the request:

Mr. Hare questioned the value of the conference to the Fairfield City School District and felt that the conference is for teachers, not board members.

Mr. Heisler asked if anyone felt that the conference would provide value for The Fairfield City School District and no one responded in the affirmative.

Mr. Kearns noted that it has been board practice not to pay for travel to conferences other than the OSBA conferences.

4. Race to the Top update – Roger Martin

We are in the home stretch of year four.

Mr. Martin stated that the January 30<sup>th</sup> Transformation Team meeting was cancelled due to the number of snow days teachers were out of the classroom; but the Assistant Superintendent, the Curriculum Director and the RttT Coordinator met with the Regional Specialist to look at the district's data.

Area B subcommittee met January 15th; Area C subcommittee met February 3<sup>rd</sup> and Area D subcommittee met February 18<sup>th</sup>.

This is year three of our roll out process.

Science teachers in grades K-12, social studies teachers in grades K-3 and social studies elective teachers and math III & IV teachers will receive professional development on the standards this year.

Area C subcommittee met to determine the professional development that will be provided related to the 115. The professional development related to the 115 will be provided on the April 11<sup>th</sup> Waiver Day.

Teachers have completed all five Formative Instructional Practices modules.

The Curriculum Director sent the Value Added Presentation given during the State Board of Education January meeting to the appropriate staff to review.

The Curriculum Director and the RttT Coordinator worked on a Growth Measures Update PowerPoint presentation to give to each building.

Administrators are registered to attend the second round of training for eTPES being offered in February & March at Butler County ESC.

The OTES will continue the work of Student Learning Objectives beyond the third year of RttT.

# B. Item for Board Action

1. Recommend approval of the urgent necessity for the renovation and repair of property located at 211 Donald Drive to accommodate student needs of The Fairfield Academy.

RESOLUTION DECLARING THAT A CASE OF URGENT NECESSITY EXISTS AND AUTHORIZING ENTERING INTO A CONTRACT WITHOUT ADVERTISING OR COMPETITIVE BIDDING FOR THE RENOVATION AND REPAIR OF PROPERTY LOCATED AT 211 DONALD DRIVE, FAIRFIELD, OHIO

WHEREAS, due to the need to renovate and repair property located at 211 Donald Drive, Fairfield, Ohio, to accommodate student needs of The Fairfield Academy, and,

WHEREAS, the renovation and repair of the building must be accomplished immediately in order to provide services for students attending The Fairfield Academy beginning August 20, 2014,

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Fairfield City School District, County of Butler, State of Ohio, that:

<u>SECTION 1.</u> It is found and determined pursuant to ORC 3313.46 that there is an urgent necessity for the renovation and repair of the property located at 211 Donald Drive, Fairfield, Ohio.

<u>SECTION 2</u>. It is further found that compliance with the procedure for advertisement and competitive bidding prescribed by ORC 3313.46 would delay the commencement of said renovation and repair for an excessive period of time causing an additional burden on the district.

<u>SECTION 3.</u> The Treasurer and the President of the Board are hereby authorized to contract without advertising and competitive bids with:

For the renovation and repair of the property located at 211 Donald Drive, Fairfield, Ohio to accommodate students of The Fairfield Academy as described above in an amount not to exceed \$450,000.00.

He reminded everyone that the district will have the last opportunity on May 6<sup>th</sup> to receive \$19 million from the state to build a new Central Elementary School, create a high school campus with a new freshman campus across the street from the high school, have two middle schools in the existing intermediate building and middle school and build a sixth elementary school in a location to be determined.

He emphasized that the \$19 million will impact the entire community and if there is no successful outcome, the opportunity for the \$19 million will be lost. The money will be awarded by the Ohio School Facilities Commission if there is a positive outcome to the vote.

He asked everyone to get as much information as they can and to be sure to vote on May 6<sup>th</sup>.
