- 2. Additional Services

Mr. Hare requested clarification on the district's exposure to a "gottcha" piece in the proposal. Paul Motylinski responded that if the scope of the project changes, then there could be a cost increase. It depends upon what the change request is.

Mr. Heisler wanted to know what happens if the scope changes. Paul Motylinski responded that he has the authority for up to \$50,000 to make changes that are not related to the contract changes.

Mrs. Shorter wanted to know if there are plans to address energy conservation and geothermal issues for future applications. Paul Motylinski stated that the district staff and the OFCC met last week with SHP to discuss LEED certification.

Mr. Heisler would like to have the addendums listed on the agreement. Paul Otten stated that he will get those to the Board.

2. Daily rate for substitute teachers – Roger Martin

Mr. Martin presented an overview of the sub teacher shortage to the Board.

Mrs. Shorter asked what the ESC service charge is for the sub services they provide. Mr. Martin advised that there is a 4% service charge.

Mr. Hare stated that he would like to protect the teachers planning periods. As for the administrators, they cannot be educational leaders if they are spending their time locating substitute teachers. He would like administration to make a recommendation.

Mr. Kearns would also like a recommendation by the administration at the next board meeting.

3. Substitute rates for classified staff – Tom Weiser

A recommendation will be presented at the next board meeting.

4. Fairfield City Schools Board representative — Butler Tech - Paul Otten

Mr. Otten presented an update on HB 59 regarding JVSD governance.

A presentation was made to the Board regarding the status of Fairfield Stadium. The administration is proposing the following:

- New entrance
- New home and endzone bleachers
- New concession stand/restrooms
- New field house
- New lights

There will be 2300 home side seats and 1000 endzone seats. In addition, 16 wheelchair and 16 bench seats will be available for handicap accessible seating. A new pressbox will be included in the plan.

If new bleachers are installed, then new restrooms are required by building code. There will be 30 women's and 16 men's facilities. The front of the building will house a concession stand.

The new fieldhouse will include:

Home & Visitor locker rooms

Restrooms for visitor side of stadium

Concessions

Meeting rooms and official rooms

Training and weight room

Storage

New lighting is also planned as part of the renovation.

Estimated costs for the project are as follows:

Mrs. Lane presented several financing options to the Board as well as potential revenue generating ideas.
