#### COMMITTEE REPORTS

A. Legislative Report – Dan Hare

Mr. Hare read the following statement:

House School Funding Bill -HB64- the House Finance and appropriations Committee met this week to accept a substitute version of the two-year state budget bill. The Finance Committee will hold hearings this week with the full House voting on the Bill around April 20<sup>th</sup>. Once the House has voted the Senate will begin consideration. Four hundred ninety-four districts are slated for an increase in funding for FY15 and FY17. One hundred sixteen districts are held harmless. I caution everyone that this is not final until the Senate acts, the bill goes through conference committee and the governor signs the bill. We shall see

Student Testing- A. J. Wagner, Member of the State Board of Education from our Region sent a letter to Senator Peggy Lerner, Chair of the Senate Education Committee expressing his concerns about the state-testing program. He points out the tests have validity issues resulting in decisions being based upon weak data. We now face more than a decade and a half of test-focused reforms with no benefit. Funds spent on testing could have been better utilized on helping children. He urged moving away from test focused reforms and encouraged a focus on sustained and meaningful investments in practices shown to be effective in improving student learning. We shall see.

### FAIRFIELD CITY SCHOOLS BOARD OF EDUCATION REGULAR MEETING APRIL 16, 2015

On a national level the U.S. Senate's Health, Education, Labor and Pension Committee unveiled a bipartisan proposal this week to re-authorize the Elementary and Secondary Education Act indicating it will give more flexibility to states and local schools by ending federal test based accountability Under No Child Left Behind. We shall see.

Regardless of what the federal government does, education is primarily a function reserved for the states. The sad news is that leaves us at the mercy of the State Department of Education that is known locally, statewide and in the nation's capital as dysfunctional. We shall see.
