#### COMMITTEE REPORTS

A. Legislative Update – Michael Berding

# Mr. Berding gave the following report:

As promised on Oct. 6th I wanted to share how poverty affected the school report cards. An analysis was done by an Ohio Superintendent using Ohio Department of Education data:

- 524 districts (83%) have 18% or more poverty, none of those districts received an "A" on Indicators Met.
- Only two districts received an "A" on Performance Index Score. One has 0% poverty and the other has 9% poverty.
- None of the 100 poorest schools, by property valuation, received above a "D" on Indicators Met.
- No Rural High Poverty District received anything higher than a "D" on Indicators Met.
- 3% of Rural Districts received an "A" or "B" in Indicators Met.
- No Small Town High Poverty District received anything higher than a "D" on indicators Met.
- No Small Town Districts received an "A" on Indicators Met, only 4% received a "B"
- All but one "A" for Indicators Met was received by a Suburban District. There is No High Poverty or Medium Poverty Districts with the Suburban District typology.
- All but one Urban District received an "F" on Indicators Met. That one received a "D". Senate Bill 298 the bill that would tighten regulations on online school enrollment for funding purposes was sent to the education section of the Senate Finance Committee (rather than the Senate Education Committee) where it was held up. The delay was presumably for further deliberations. This matter probably won't be resolved this year. The Senate President told Gongwer News Service that the "debate over enrollment and attendance standards charter for online schools is probably 'too big to handle' in the post-election session."

In related news, on September 30 Franklin County Common Pleas Judge Jenifer French denied a request by ECOT, the state's largest online charter school, to stop the state from requiring that it produce attendance records to justify the \$106 million it got last year in state funding.

French ruled in favor of the Ohio Department of Education, rejecting a preliminary injunction request by the ECOT that would have immediately blocked the state from using log-in records and other data to determine how many full-time students actually attend the school. The ruling comes four days after the Department of Education informed ECOT that, based on its attendance audit, the district's reported enrollment last year was inflated by 143 percent. Instead of the 15,322 full-time students that ECOT was paid for, the actual number is 6,313.

The ruling means ECOT could be forced to repay more than \$60 million of the \$106 million it got in state funding last year.

Eight other e-schools also have struggled to produce data showing students are meeting the 920 hours required to be considered a full time student.

Judge French wrote: "The court finds there is a public interest in ensuring that our children are receiving the education that our taxpayers are funding."

On Tuesday I attended a seminar hosted by Senator Bill Coley addressing the newly enacted Medical Marijuana law. The new law allows Ohioans to use medical marijuana only if they are diagnosed with one of twenty-one severe medical conditions and will not be available in a combustible form. Medical marijuana won't be available for two years, but the seminar suggested business, local governments and school districts should start addressing policies that might be affected by the new law. Policies such as employee drug testing, student drug use, and drug-free workplace policies should be updated to protect students' rights, as well as protect school districts from potential legal loopholes. As the law is written, no business can operate a distribution,

cultivation, or a retail medical marijuana business within 500 feet of a school, but it does not protect other school property, such as an athletic complex or stadium. Schools are encouraged to work with their local government to ensure all school property is protected from these businesses.

# B. Butler Tech – Michael Berding
